IMPORTANT INFORMATION ABOUT AN EXTENSION OF TIME

The following matters are to be considered in determining whether to extend the time of a permit.

- The Responsible Authority should treat the applicant as being obliged to advance some reason or material in support of the grant of an extension, (Reason for Extension) and

The Responsible Authority may rightly consider

- Whether there has been a change of planning policy.
- Whether the landowner is seeking to “warehouse” the permit.
- Intervening circumstances as bearing upon grant or refusal.
- The total elapse of time.
- Whether the limit originally imposed was adequate.
- The economic burden imposed on the landowner by the permit.
- The probability of a permit issuing should a fresh application be made.
