Mildura Rural City Council, with the assistance of Mesh Planning, is seeking feedback on the aspirational themes and draft emerging directions for Irymple.

What are aspirational themes?

The aspirational themes refer to what Irymple should be or should have in the next 15 years based on feedback from Consultation 1 and findings from early research and analysis. There are five aspirational themes:

1. A distinct town that supports its growing community
2. Integrated neighbourhoods and precincts
3. Safe and purposeful connections
4. A greener town
5. An identifiable and attractive community hub.

What are emerging directions and options?

High-level ideas and draft concepts that seek to respond to key challenges and direct thinking towards a preferred future outcome for Irymple. The emerging directions relate to the precinct's character and identity, land use, transport, and community infrastructure such as open spaces.

Emerging directions and options are meant to be tested and refined. Once finalised, they will be incorporated into the *Draft Irymple Structure Plan and Urban Design Framework*.

Every response helps us refine the project output and assists with informing the *Draft Structure Plan and Urban Design Framework*.

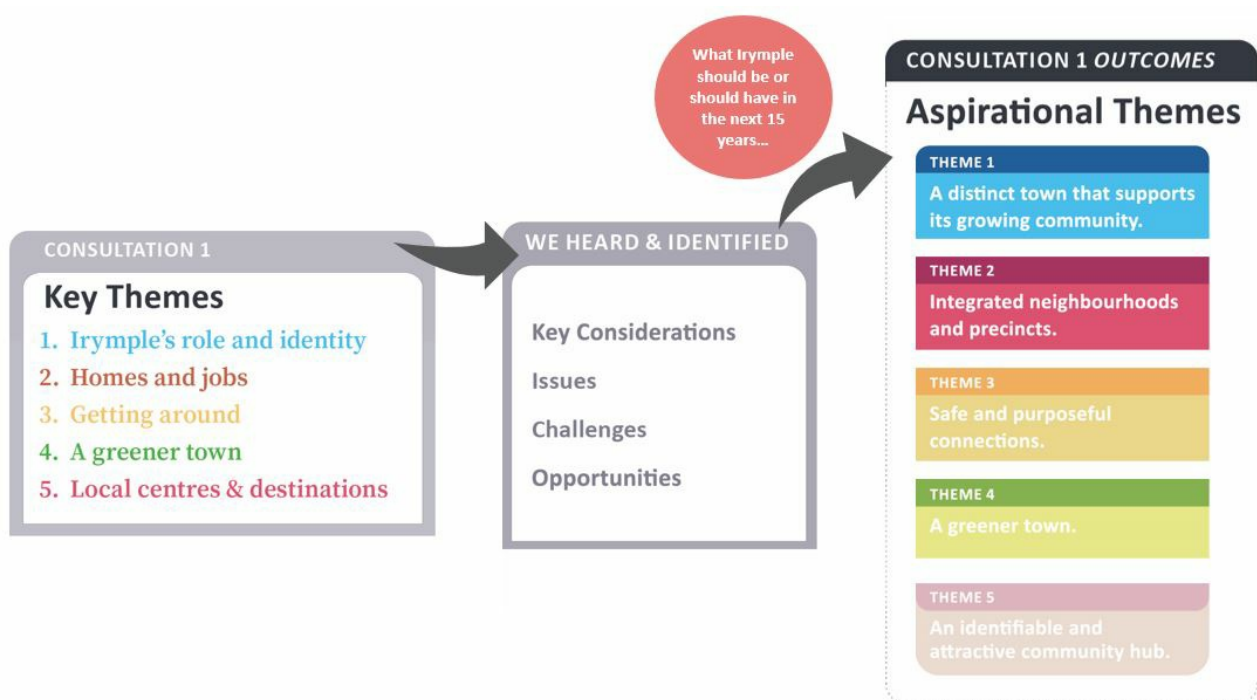

Our process has involved:

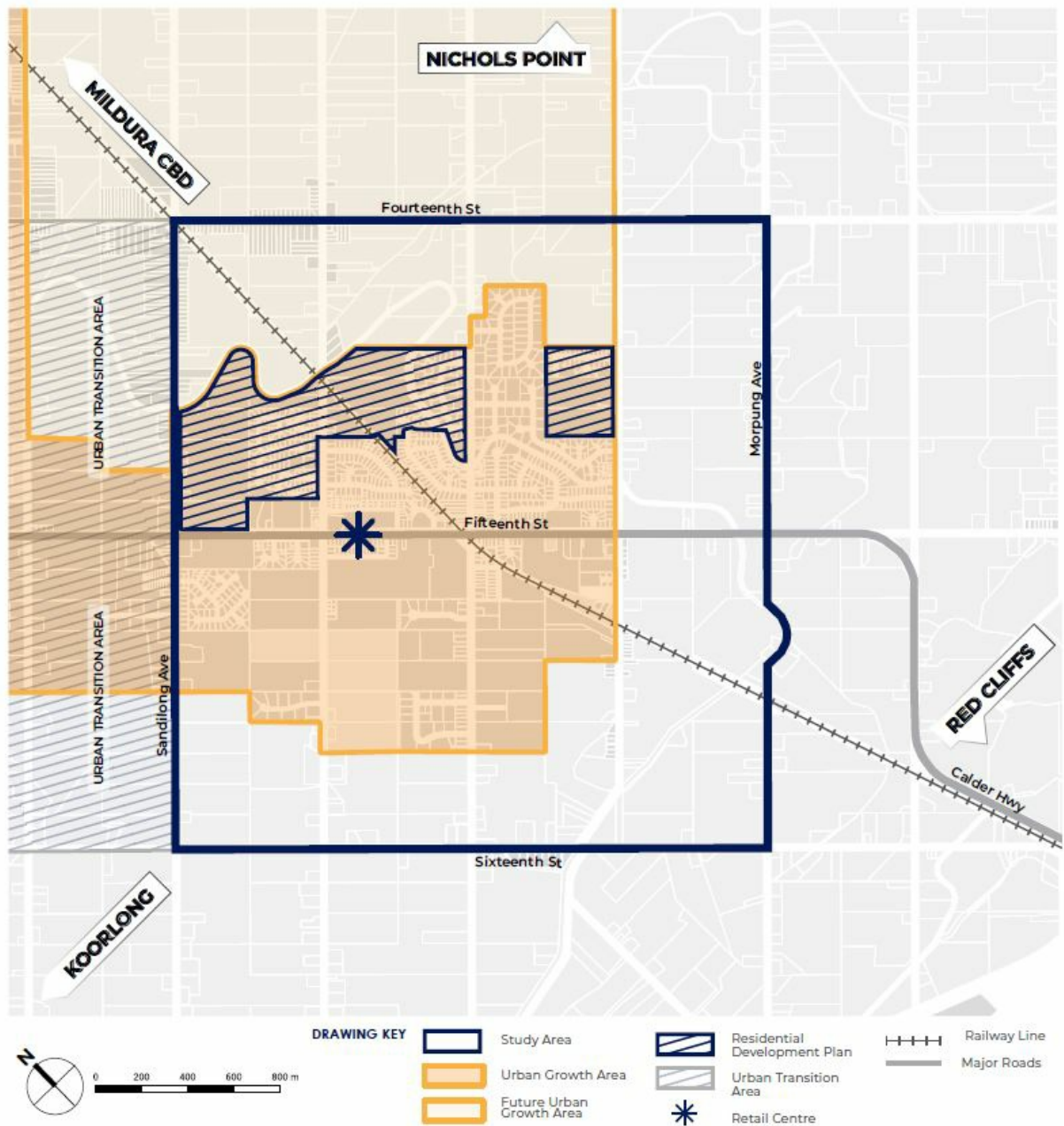
- Summarising and analysing what we heard from Consultation 1 based on the five (5) consultation themes;


