The Strategic Vision and Objectives Paper has been prepared as part of the planning for Deakin Avenue's future. The paper is out for public comment until Friday 16 October 2015. This is your opportunity to review the vision and We are here development future along Deakin Avenue.

THE PROJECT

The project aims to develop a guiding framework for future development along Deakin Avenue from Seventh Street to the bend near Gordon Avenue. The project's focus is on the buildings and land uses either side of Deakin Avenue, as well as the design of the footpaths and nature strip (the central median strip landscape already has a Council approved plan).

The development of a clear vision for Deakin Avenue, along with detailed design principles will assist in guiding future development that is:

- Located appropriately
- Achieves a high quality built form outcome
- Provides a functional and attractive public realm
- Contributes to a strong and consistent image, and
- Respects the Avenue's unique character and sense of place



WHAT HAS HAPPENED SO FAR?

Stage 1 of the project included undertaking consultation workshops, a community survey and a site survey, to gather all the background information and an understanding of the issues and opportunities available along the Avenue. A Key Issues Report was prepared to detail these issues and opportunities.

Following the issues stage, a preliminary vision and overarching principles were presented to the community and stakeholders during two days of 'visioning' workshops. The workshops stimulated ideas and provided discussion about the future vision and direction for Deakin Avenue.

The paper builds on the feedback received through the 'visioning' workshops to present a vision and overarching guiding principles for the future of Deakin Avenue.

Key design elements are also described in the paper to address the issues highlighted and help achieving the vision developed for Deakin Avenue. The paper also identifies five precincts along the Avenue, with each precinct having individual characters, precinct objectives and suggested actions illustrated on maps.
