Mildura Planning Scheme Notice of the preparation of an amendment to a planning scheme Amendment C121mild

The amendment has been prepared by Mildura Rural City Council, which is the planning authority for this amendment.

The amendment has been made at the request of the landowner.

The amendment applies to land at 13 Dal Farra Road, Irymple, being Lot 1 TP674265 and Lot 1 TP232429.

The amendment proposes to:

- Rezone the land from the Farming Zone (FZ) to the Low Density Residential Zone, Schedule 1 (LDRZ1) to facilitate its use for low density residential development.
- Apply the Design and Development Overlay, Schedule 16 (DDO16 – 13 Dal Farra Road, Irymple) to the land.
- Apply the Development Plan Overlay, Schedule 2 (DPO2 – Low Density Residential Areas) to the land.

Council is seeking feedback on our Draft Urban Forest Strategy.


